To help our limited fund reach more children, we ask families requesting assistance to pay as much as they can toward their camp fee, especially if they are requesting programs that are more expensive than basic resident or day camps. Maximum campership per child is up to \$280 for a 3-day/2-night camp, \$280 for a 5-day Day Camp, and up to \$420 for a 6-day/5-night camp. Each child can only receive a total of the maximum assistance amount one time.

Before completing this application, you should have communicated directly with the requesting family to confirm the specific dollar amount of assistance this family is requesting from Camp Bethel. The dollar amount of assistance requested would be the cost of the program (Subsidized Fee) minus the amount the family can pay toward the camp fee.

How to Apply for Camp Bethel Campership Financial Assistance

This form can be completed and submitted on line at: www.CampBethelVirginia.org/help. *Complete this form ONLY if you are a pastor, social worker, agency worker, or school guidance counselor confirming this family's need for financial assistance in the form of a "campership" from Camp Bethel.* Our limited fund for partial or full camperships is available to help families who qualify for reduced school meals in Virginia. See the Needs Calculator Chart for eligibility below, or email the Camp Director to discuss a specific situation. To help our limited fund reach more children, we ask families requesting assistance to pay AS MUCH AS THEY CAN toward their camp fee, and especially if they are requesting programs that are more expensive than basic resident or day camps. Maximum campership per child is up to \$400 for a 6-day/5-night camp and up to \$250 for a 3-day/2-night camp and \$250 for a 5-day Day Camp program.

INSTRUCTIONS:

1. Parent: Choose your program and dates. www.CampBethelVirginia.org/Camps
2. Parent: Review our Needs Calculator Chart below. Our limited Campership Fund is available to help families who qualify for free-or-reduced school meals in Virginia. You may also email the Camp Director (CampBethelOffice@gmail.com) to discuss your specific need. Alternately, most Virginia District Churches will assist families in their community with funding for summer camp or with "Good-as-Gold" for summer camp.
3. Parent: Calculate your exact requested amount of assistance. Decide how much you can afford to pay toward the camp fee. We ask families to pay as much as they can so that our Campership Fund can reach more families. Maximum campership per child is up to \$250 for a 3-day/2-night camp, \$250 for a 5-day Day Camp, and up to \$400 for a 6-day/5-night camp. What is the cost of your chosen program? Subtract what you can pay from the Subsidized Fee for your chosen program. The difference is the amount you are requesting in assistance.
4. Parent: Communicate your program, dates, and your exact requested amount of assistance to your pastor, social worker, agency worker, or school guidance counselor.
5. Parent: Have your pastor, social worker, agency worker, or school guidance counselor complete and submit the on-line Campership Financial Assistance Application below, OR have them complete and submit a paper form, *(reverse side)*. *We prefer the on-line form.*
6. Parent: Complete the on-line Summer Camp Registration Form (<https://forms.gle/xLk6ipPsoManTW27A>). A printable Summer Camp Registration Form is available for print at CampBethelVirginia.org/help at the bottom of the page. *Alternately, use paper forms and mail them to camp together.*

Camperships are granted first-come, first-served, only one per camper per summer, and camperships are currently only available through this Campership Financial Assistance Application. Maximum campership per child is up to \$250 for a 3-day/2-night camp or 5-day Day Camp, and up to \$400 for a 6-day/5-night camp. A response email will inform families of granted campership requests.
